In 2023, Groundswell Fund **supported 258 grantees in 49 states and territories and hundreds of thousands of people in diverse communities** to advance intersectional reproductive and social justice causes and systems change.

We are home to **five funds** that allow us to move money to communities with the clearest vision for what we need to win.

OUR GRANTMAKING PROGRAMS



CATALYST FUND

ESTABLISHED IN 2013

The Catalyst Fund supports the nation's strongest reproductive justice organizing led by **women of color, low-income women, and transgender people**. We prioritize efforts that use grassroots organizing to advance policy and systems change.

While centering efforts led by women of color, the Catalyst Fund also supports work led by low-income white women and transgender people. Together, these constituencies experience the most significant reproductive health disparities and the most considerable barriers to reproductive freedom in the United States.



BIRTH JUSTICE FUND

ESTABLISHED IN 2011

The Birth Justice Fund resources organizations confronting disparities in pregnancy and birth outcomes for **women of color, low-income women, young women, queer, and transgender people**. We aim to increase access to empowering and culturally relevant birthing options, uplift the leadership of midwives, doulas, and other birth workers of color, and support lasting changes in policy and practice.

LIBERATION FUND

ESTABLISHED IN 2016

The Liberation Fund supports the most effective and powerful grassroots organizing efforts in the United States today. Recommended by a diverse board of advisors from the field, grantees are nonprofits led by people of color and transgender people of color across various social change movements.



RAPID RESPONSE FUND

ESTABLISHED IN 2016

The Rapid Response Fund provides timely, flexible grants responding to critical, unexpected fights to protect or advance reproductive and social justice.



BLACK TRANS FUND

ESTABLISHED IN 2020

Incubated by Groundswell Fund, the Black Trans Fund is dedicated to uplifting, resourcing, and building the capacity of Black transgender social justice leaders. This effort is rooted in the legacy of Black transgender freedom fighters and guided by liberation and joy. As the first national fund in the United States led by and for Black transgender people, this is a groundbreaking endeavor.

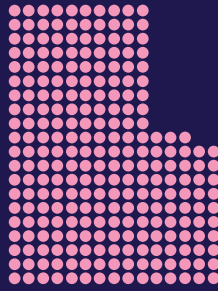

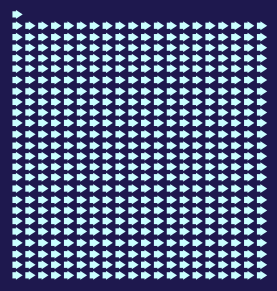

Supporting Movements in Their Most Pressing Moments

Our grantees face a different world today than they did ten years ago, with more significant needs, more urgent timelines, fiercer opposition, and the same often-strapped budgets.

After the repeal of *Roe v. Wade*, states introduced 563 bills restricting access to abortion. With escalating attacks on bodily autonomy and voting rights alongside a global trend toward fascism and white supremacy, **investment in intersectional grassroots organizing is critical.**

Supporting long-term infrastructure building has been a deep focus for Groundswell since our inception—**we see that strategy pay off time after time**. When grantees can sustain permanent infrastructure, they can proactively gain ground and respond when challenges emerge.

Throughout 2023, **Groundswell continued to support our grantees' sustainability and long-term impact** to retain the durable infrastructure they need to proactively respond to challenges and take swift action to fight for our future and the liberation of all people.

Progress on 2023 Goals and Groundswell's 5-Year Blueprint

Groundswell has moved over **\$80 million** to critical efforts under our Blueprint plan, a bold **commitment to move \$100 million** to the field between 2020-2025 (\$80M via Groundswell Fund and \$20M via Groundswell Action Fund). We are on track to exceed our original goal by the end of 2025.

Groundswell raised approximately **\$28 million** from our generous funders and donors, moving closer to our goal of increasing annual investment in organizations led by Black women, Indigenous women, and trans and gender-expansive people of color.

CATALYST FUND FOR REPRODUCTIVE JUSTICE

IN 2023 → \$4.7M TO 63 GRANTEES

The Catalyst Fund for Reproductive Justice grantees organized their communities to make decisive victories in Ohio, Kansas, and other states while defending reproductive health and abortion access locally and nationally.

With a particular focus on frontline regions in the South, Southwest, and Midwest, **grantee partners took bold measures to defend and advance reproductive justice** in a hostile climate of increased restrictions and governmental policing of the bodies of Black and Brown women, transgender, and gender-expansive people.

GRANTEE PARTNERS IN ACTION

Unite for Reproductive & Gender Equity (URGE)

Building power and sustaining a young people's movement for reproductive justice

In 2023, Groundswell's Catalyst Fund grantee **URGE** supported youth of color and LGBTQ youth organizing around the Ohio ballot initiative to restore and preserve abortion access. URGE collected signatures and co-led the campaign to get abortion on the ballot last November.

URGE, in partnership with the Ohioans for Reproductive Freedom, filed over 700,000 signatures and succeeded in placing *The Right to Reproductive Freedom with Protections for Health and Safety Amendment* on the 2023 General Election ballot.

Ohio was the only state to include abortion on the ballot for November 2023. Ohio voters approved the measure by a margin of 56.6% to 43.4%, marking the first time a Republican-controlled state has affirmed the right to abortion in its state constitution.

Colorado Organization for Latina Opportunity and Reproductive Rights (COLOR)

Working to enable Latinx individuals and their families to lead safe, healthy, self-determined lives

In 2023, Catalyst Fund grantee COLOR, in partnership with New Era Colorado, organized heavily around SB23-190, making Colorado the first state to regulate abortion pill reversal, an unproven and experimental practice offered by anti-abortion centers that target youth and communities of color across Colorado.

The passage of SB23-190 helps ensure that abortion is legal and that all reproductive care offered in Colorado is safe and transparent. In coalition with other reproductive health and justice organizations, COLOR also filed language for a groundbreaking 2024 ballot measure that will enshrine the right to abortion care into the state constitution and ensure every Colorado person can exercise that right regardless of the source of their insurance coverage.

IN 2023 → \$2.0M TO 40 GRANTEES

Last year was incredibly exciting as we launched **three fresh initiatives around birth justice**: a partnership between the Black Trans Fund and the Birth Justice Fund, a grantee partner pipeline for our Grassroots Organizing Institute, and the launch of our Financial Resilience Capacity Building offering.

Groundswell's Birth Justice Fund and the Black Trans Fund partnered to grant \$300,000 to two national projects focused on identifying and amplifying Black trans movement priorities within reproductive and birth justice.

Our Birth Justice Fund also partnered with our Grassroots Organizing Institute to create a pipeline for up to three grantee partners to join the institute in 2024 and assess the challenges that Birth Justice grantees face in implementing organizing strategies.

We continued to partner with BDO FMA to complete the first year of an inaugural Financial Resilience Capacity Building program, which offered free, tailored financial management training for Birth Justice grantees grounded in equity, justice, and liberation values.

GRANTEE PARTNERS IN ACTION

Ancient Song

Eliminating maternal and infant mortality and morbidity among low-income Black and Latinx people

Ancient Song, a national birth justice organization, continued to advance key policy and advocacy work in 2023 focusing birth equity and community-led solutions at the local, state, and federal levels.

After years of advocacy and organizing doulas, birthworkers, and other grassroots leaders in New York State, Ancient Song celebrated the passage and signing of a bill that will create a directory of doulas and enforce a new policy allowing doula services to be eligible for Medicaid reimbursement as of January 1, 2024.

Ancient Song advocated for these changes in a way that centers community-based birth workers serving Black and Brown birthing people across the state. They were present at the bill signing alongside other New York birth justice advocates. They plan to continue engaging with the bill over the next year to ensure its implementation is accountable to the community and doulas.

Black Mamas Matter Alliance (BMMA)

Advancing Black maternal health, rights, and justice

In April 2023, BMMA held their annual Black Maternal Health Week, which calls attention to Black maternal health advocacy, policy changes, research, advancing care, and shifting culture.

During that time, BMMA launched its comprehensive policy agenda, which reflects the learning and recommendations needed to address the Black maternal health crisis.

Many of BMMA's policy recommendations are now included in pending federal legislation, including Medicaid expansion for postpartum and low-income adults, which is associated with reductions in maternal and infant mortality. The policy agenda also expands ways for

Medicaid to support more diverse perinatal workforces, including more doulas and midwives, and prioritize perinatal mental health care.

\$1.5M TO 17 GRANTEES

Throughout the year, our Liberation Fund grantees **fought against gentrification and unfair housing evictions, organized for Black liberation, fought for the dignity, worker's rights, and safety of transgender and gender-expansive people, and organized for climate and environmental justice.**

In 2023, the Liberation Fund made its first specific grants for Climate Justice work through a \$100,000 grantmaking partnership with Astraea Lesbian Foundation.

Our Liberation Fund grantee partners are building a vibrant grassroots base with the scale, sustainability, and integrity necessary to win large-scale social change and dramatically improve the material conditions of those at the intersection of race, class, and gender oppression.

GRANTEE PARTNERS IN ACTION

Mujeres Unidas y Activas (MUA)

Promoting personal transformation and building community power for social and economic justice

MUA trains member-leaders in California to lead organizing campaigns for immigrants, workers, and women's rights. Through their statewide campaigning, MUA led efforts in finalizing the Domestic Worker Health and Safety Act, approved in California state legislature in November 2023, making domestic worker health and safety guidelines enforceable.

MUA also served on the California Domestic Workers Coalition, helping to solidify a permanent new state budget for the Domestic Worker and Employer Outreach Program, which will distribute funding to community-run domestic worker and employer outreach programs statewide.

Black Youth Project 100 (BYP100)

*Creating justice and freedom for
all Black people*

In 2023, BYP100 celebrated a vote by Chicago’s Community Commission on Public Safety and Accountability to erase the city’s racist and ineffective gang database. This vote came after years of BYP100 working with other community organizations in the Erase the Gang Database coalition to get rid of a system that unfairly targets and criminalizes Black and Brown people.

Community groups held rallies, protests, and press conferences, as well as drove petitions and filed lawsuits to end the database, which was deemed ineffective by the city’s Inspector General in an April 2019 audit. Though the coalition knows this is just the first step in ending the city’s harmful surveillance practices, BYP100 is committed to ensuring no other databases are created and that those harmed by this system are made whole again.

RAPID RESPONSE FUND

IN 2023 → **\$820K** TO **96** GRANTEES

The central themes of our 2023 Rapid Response Fund grantmaking included **abortion access, reproductive justice, Palestine solidarity efforts, transgender rights, police accountability, and civic engagement in preparation for a crucial 2024 election year.**

RRF collaborated with Groundswell's Birth Justice Fund to disperse \$40,000 in grants to organizations responding to the Maui fires with relief and recovery aid for birthing people and postpartum families.

We also launched the Rapid Response Funder Coordination Table, which includes 15 social justice funders nationwide to address urgent and timely requests from movement-building organizations and move additional dollars to their efforts.

GRANTEE PARTNERS IN ACTION

I Be Black Girl

Helping Black women, femmes, and girls actualize their full potential through autonomy, abundance, and liberation

Last year, I Be Black Girl, a Nebraska-based reproductive justice organization, organized around the LB626 abortion ban, which bans abortions after six weeks of pregnancy, resulting in a modified 12-week amendment to the current abortion ban.

Informed by a mix of medical experts and community members, I Be Black Girl campaigned for language changes to the current amendment that would push abortion past 20 weeks, similar to other ballot initiatives across the country.

They have continued to push for petition language in Nebraska, similar to other states like Ohio and Kansas, that would spearhead ballot initiative work for the 2024 elections.

Florida Rising

Building independent civic power in Florida that centers historically marginalized communities to advance racial and economic justice

In May 2023, the Jacksonville City Council agreed to settle a federal lawsuit charging that the city has long deployed an unconstitutional, racially gerrymandered voting district map that denied Black voters fair representation in city council and school board elections.

Florida Rising was one of the ten plaintiffs in the settlement, which resulted in using a new redistricting map that will include insight from experts, activists, and citizens, marking a critical step toward ensuring fair representation for the city’s Black residents.

IN 2023 → **\$1.7 M TO 59 GRANTEES**

Black Trans Fund's 2023 focus was strategizing around liberation and visibility, prioritizing the health and well-being of grassroots organizing leaders, and launching our Arts and Culture Fellowship.

Black Trans Fund's grantee partners were at the forefront of strategizing around Black trans liberation and visibility, focusing on joy and thriving instead of centering pain and trauma. Last year, the Black Trans Fund collaborated with Groundswell's Birth Justice Fund to allocate \$300,000 toward two national projects. These projects aim to identify

and elevate the priorities of the Black trans movement within the realms of reproductive and birth justice.

BTF also tended to the health and well-being of organizational leaders and community care for members amidst increased attacks on trans rights and bodily autonomy. We closed the year by launching the inaugural Arts and Culture Fellowship, which offered project support, education, and capacity-building for Black trans artists and arts organizations nationwide.

GRANTEE PARTNERS IN ACTION

Chosen Kin

Building community through storytelling and art-making for Black queer and trans parents

Based in Philadelphia and New York, Chosen Kin supports a national network that honors Black queer and trans parenthood, connecting the community with healing spaces for Black liberation and centering joy, rest, care, and ancestral healing.

Led by Black trans and nonbinary Black parents, Chosen Kin organizers hold playdates, family retreats, and a bi-weekly virtual parent support space to create an advocacy and support network for Black trans, gender-expansive youth, and parents.

The organization supports parents and caregivers who have experienced increased attacks and challenges navigating transition-related healthcare and supportive services. This is a result of state-based anti-trans legislation aimed at instilling fear and confusion in families supporting trans youth.

Brown Boi Project (BBP)

Building leadership, economic self-sufficiency, and health

BBP is a grassroots community organization of Black and gender-expansive people of color who predominantly identify as masculine of center, transmasculine, two-spirit people, and allies committed to changing how communities of color talk about gender.

Founded in Oakland, BBP develops leaders who intend to bring a strong racial and gender justice lens to their work. Through leadership development, network resilience cultivation, healing justice, financial education, and exposure to community organizing, BBP has worked to cultivate safe spaces to explore and develop liberatory frameworks around gender.

With support from the Black Trans Fund, BBP hosted the Freeing Ourselves Florida-based youth leadership pilot initiative in partnership with S.O.U.L. Sisters leadership. Through this pilot project, BBP engaged in virtual training sessions to gather Black trans masculine and gender-expansive youth from Southern States to develop a “liberatory masculinities” toolkit to support participants in facilitating their own gender justice/masculinity groups in their local communities.

IN 2023 → **\$6.5M TO 33 GRANTEES**

Groundswell exceeded our 2023 goal of moving \$5 million in total capacity-building support to the field. This funding contributed to building the intersectional organizing and civic engagement infrastructure needed to power women, transgender, and gender-expansive people color-led organizations.

Outside of grantmaking, we provided other critical opportunities such as the nonpartisan

Integrated Voter Engagement program, the Grassroots Organizing Institute, our first Digital Security 101 training in partnership with Equality Labs, and co-sponsored a legal workshop with the Robert Wood Johnson Foundation and other social justice funders to provide additional security trainings amidst increased criminalization and digital attacks against activists and movement groups.

INTEGRATED VOTER ENGAGEMENT GRANTEE PARTNER IN ACTION

Groundswell's Integrated Voter Engagement (IVE) provides grants, training, convening, coaching, and legal and technical support for grassroots organizations to integrate nonpartisan voter engagement strategies into their work and to boost their scale and ability to achieve systems change.

Freedom, Inc.

Achieving social justice through coupling direct services with leadership development and community organizing

In Dane County, Wisconsin, Freedom, Inc., fiercely advocates for the bodily autonomy of Black queer, trans individuals, and Black youth facing domestic violence and sexual assault.

Throughout 2023, Freedom Inc.'s community members and organizers passionately fought, mobilized, and bolstered electoral influence. Their active participation in the election resulted in the election of more State Supreme Court justices aligned with their values.

Furthermore, their relentless efforts yielded victories in the Dane County Circuit Court rulings on July 7 and August 14, 2023. These rulings solidified Wisconsin Stat. 940.04, allowing for consensual medical abortions. Undeterred, Freedom Inc. remains steadfast in their organizing efforts, striving to enshrine bodily autonomy in Wisconsin's legislation throughout 2024.

Groundswell's Grassroots Organizing Institute (GOI) provides grants, training, convenings, and coaching in a year-long training program to support grassroots organizations to deepen their understanding and practice of the fundamentals of grassroots organizing and advocacy for systems change.

Afiya Center

Transforming the lives, health, and overall well-being of Black womxn and girls

As a Black women-led organization, The Afiya Center is dedicated to providing refuge, education, and resources around abortion access, voting rights, and birth justice to achieve reproductive freedom.

In April 2023, Afiya Center represented the Jackson family, whose four-day-old newborn was taken by Dallas authorities following their home birth and decision to keep their newborn under their midwife's care. The center launched a three-week national campaign, using hashtags #BringMilaHome and #JusticeForMilaJackson, to place pressure on elected officials and child welfare agencies to return baby Mila Jackson to her family.

On April 20, the Dallas County's district attorney's office released Mila to her family after weeks of public rallies fighting against the criminalization and violation of rights for Black parents, children, and midwives. This is just one of many ways The Afiya Center serves as a leading advocate for full reproductive spectrum care, challenging the inequities in healthcare for Black communities in Texas.

PUSHING PHILANTHROPY FORWARD

A crucial part of Groundswell's larger strategy is to catalyze greater commitment to reproductive and social justice movements within philanthropy.

We expand our impact and that of our grantee partners by drawing new resources to powerful work, deepening existing partnerships with other funders, and positioning thought leadership in influential spaces.

Our funder organizing consists of two components:

FUNDER AND DONOR EDUCATION

Groundswell conducts **annual funder briefings** to connect funders and donors to grassroots leaders, lift success stories, challenges, and lessons learned, and provide educational opportunities for philanthropic colleagues seeking to optimize the impact of their giving.

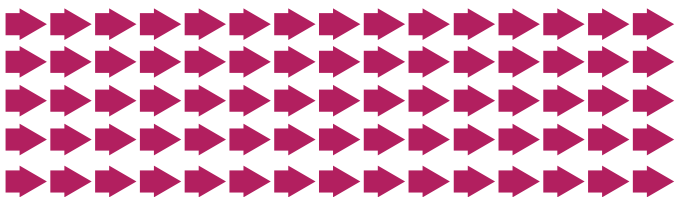

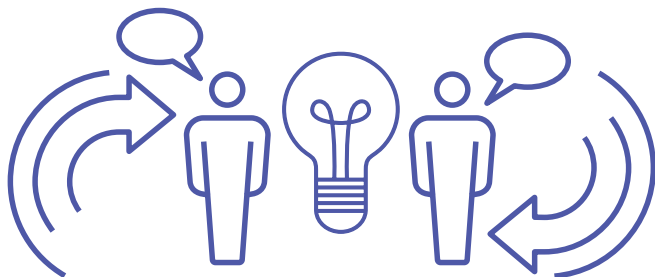
Groundswell staff amplify the needs and strategic value of grassroots organizing led by women of color in funder affinity groups and donor networks to increase dollars moving to the field. We do this whether or not the funds come through our doors. Currently, **we are active in 10 funder and donor affinity groups and networks**, most recently organizing within Funders for Reproductive Equity, Funders for Birth Justice and Equity, Change Philanthropy, and Funders for LGBTQ Issues to move more resources to the field.

Press Coverage Highlights

In 2024, we plan to invest in growing our funder organizing capacity to anticipate future revenue changes as the fundraising landscape evolves and deepen our partnerships with our peers for short-term wins and long-term systems change.

BUILDING ROBUST INFRASTRUCTURE TO CHAMPION MOVEMENTS

Since our inception over 20 years ago, Groundswell has moved over **\$183 million to grassroots movements (c3 and c4 combined)**, built the capacity of thousands of organizations, and organized thousands of donors and funders to fund reproductive and racial justice.

Groundswell Fund has become a critical contributor to the larger philanthropic ecosystem, growing to a \$30 million budget and attracting brilliant and talented staff directly from community, labor, and electoral organizing.
